Pet Owner agrees to advise Red Star Kennel of any change in the medical history, medications or the specific care of their pet. Red Star Kennel is obligated to recontact the pet owner or vet to initiate any updating of the medical information provided on this pet. Red Star Kennel will not be responsible for anything as a result of the pet owner's failure to keep any medical or pertinent information current. This agreement stays in effect until specifically revoked by either Red Star Kennel or Pet Owner.

This is a contract between Red Sate Kennel and the pet Owner whose signature appears above (hereinafter called Owner).

1. Owner agrees to pay the rate for boarding in affect on the date pet is checked into Red Star Kennel. (As indicated on this contract)

2. Owners further agree to pay all costs and charges for special services requested, and all veterinary costs for the pet during the time sole pet is in the care of Red Star Kennel.

3. Owner further agrees that the pet shall not leave Red Star Kennel until all charges are paid to Red Star Kennel by Owner.

4. Red Star Kennel is not responsible for any damages or loses of property (Beds, Blankets, toys, etc.) during pets stay.

5. By signing this contract and leaving his/her pet with Red Star Kennel, Owner certifies to the accuracy of all information given about said pet on this contract.

6. Red Star Kennel shall exercise reasonable care for the pet delivered by the Owner to Red Star Kennel for boarding. It is expressly agreed by Owner and Red Star Kennel that Red Star Kennel's liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or sum of \$200.00 per animal boarded. The Owner further agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of Red Star Kennel.

7. Owner specifically represents that he or she is the sole owner of the pet, free and clear of all liens and encumbrances.

8. Owner specifically represents to Red Star Kennel that the pet has not been exposed to Rabies or Distemper within a thirty day period prior to boarding.

9. All charges incurred by Owner shall be payable upon pickup of pet, or when billed by Red Star Kennel at address listed on contract. Red Star Kennel shall have and is hereby granted a lien for the pet an any and all unpaid charges resulting from boarding pet at Red Star Kennel. The Owner hereby agrees that in the event the boarding charges are not paid when due in accordance with this contract, Red Star Kennel may exercise its lien rights upon 10 days written notice given by Red Star Kennel to Owner by certified mail to address shown on this contract. Red Star Kennel may dispose of pet for any and all unpaid charges, at private or public sale, in the sole discretion of Red Star Kennel, and Owner specifically waives all statutory or legal rights to the contrary. If such sale should not secure a price adequate to pay such cost of board or other charges delinquent, plus costs of sale, then Owner shall be liable to Red Star Kennel for the difference. All moneys realized by Red Star Kennel at such sale, over and above the charges due and cost of sale, shall be paid by Red Star Kennel to Owner.

10. If pet becomes ill or if the state of the animals health otherwise requires professional attention, Red Star Kennel, in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite to the animal, and the expenses thereof shall be paid by the Owner.

11. This contract contains the entire agreement between the parties. All terms and conditions of the Contract shall be binding on the heirs, administrators, personal representatives and assigns of the owner and Red Star Kennel.

12. Any controversy or claim arising out of or relating to this contract, or the breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this contract, shall be settled by arbitration in accordance with the rules of the American Arbitration Assoc. and judgment upon the award rendered by an arbitrator may be entered in any court having jurisdiction thereof. The arbitrator shall, as part of his award, determine an award to the prevailing party of the cost of such arbitration and reasonable attorney's fees of the prevailing party.
